Concerns have been expressed by Councillors regarding both internal and external audit failing to identify that annual rent reviews have not been carried out over a number of years resulting in rises now being proposed that endanger the existence of valuable Community assets.

Cllr C Parker brought to the attention of Council serious concerns about the continuing viability of Bucklands CC if the proposed rent increase was implemented. Cllr Hall at the recent Council meeting (5 September 2023) declared an interest and explained in support of Cllr C Parker the value of Bucklands to the Community.

Cllr R Keeling informed Council that the proposed rent increase will not be applied for the current financial year (2023/2024) and requested that O & S carry out an urgent review of the policy and its implementation.

Following a debate at Council there was a cross party consensus that this was an issue that should be a priority for O & S members to consider carrying out as it is of high local importance and community value.
