- Your spouse or civil partner, or a person with whom you are living as husband or wife or as civil partner provided you are aware that other person has the interest ("Partner Interests").
- You must register in Appendix B of this Register all your other interests as required by the Council's Code of Conduct.
- 3. You must register both DPIs and any other interests within 28 days of whichever is the later of:
- a. the date that the Council adopts a Code of Conduct
- b. of your election, appointment or co-option on to the Council.
- 4. You must register, by writing and telling the Council's Monitoring Officer, of any new interest (or change to any interest already registered) within 28 days of that new interest or change.
- You must notify the Monitoring Officer within 28 days of any interest disclosed at a meeting that is not already in the Council's Register or already been notified to the Monitoring Officer.
- 6. The information that you provide on this form will be kept in a Register by the Monitoring Officer which is required to be available for public inspection and will also be published on the Council's website.
