- 4. You must register, by writing and telling the Council's Monitoring Officer, of any new interest (or change to any interest already registered) within 28 days of that new interest or change.
- 5. You must notify the Monitoring Officer within 28 days of any interest disclosed at a meeting that is not already in the Council's Register or already been notified to the Monitoring Officer.
- 6. The information that you provide on this form will be kept in a Register by the Monitoring Officer which is required to be available for public inspection and will also be published on the Council's website.
