It is for these reasons that I must object to this application being granted.



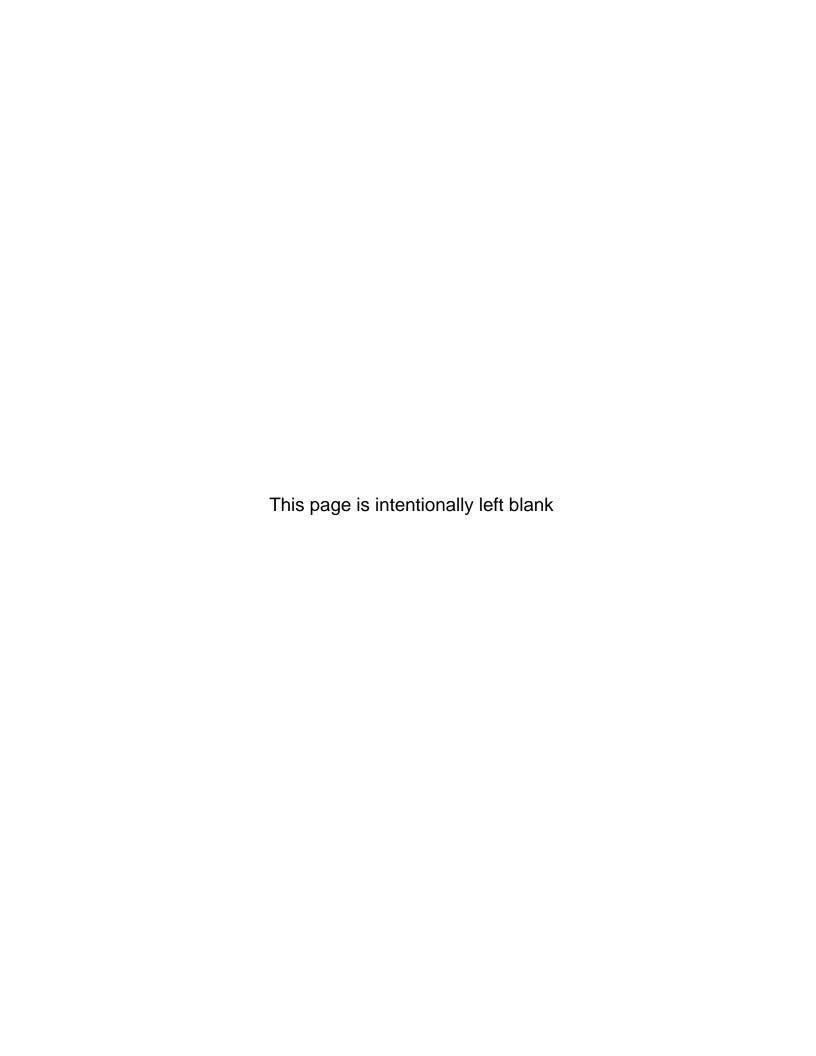
