I have tolerated live and recorded music on numerous occasions knowing that it will stop at 22.30/23.00. The possibility of entertainment continuing until midnight any day of the week would be intolerable.

The pictures I have attached were taken from within my home. The windows behind where the bands etc perform are often opened during the warmer months and the noise is even greater. A public nuisance.

It is for these reasons that I must object to this application being granted.

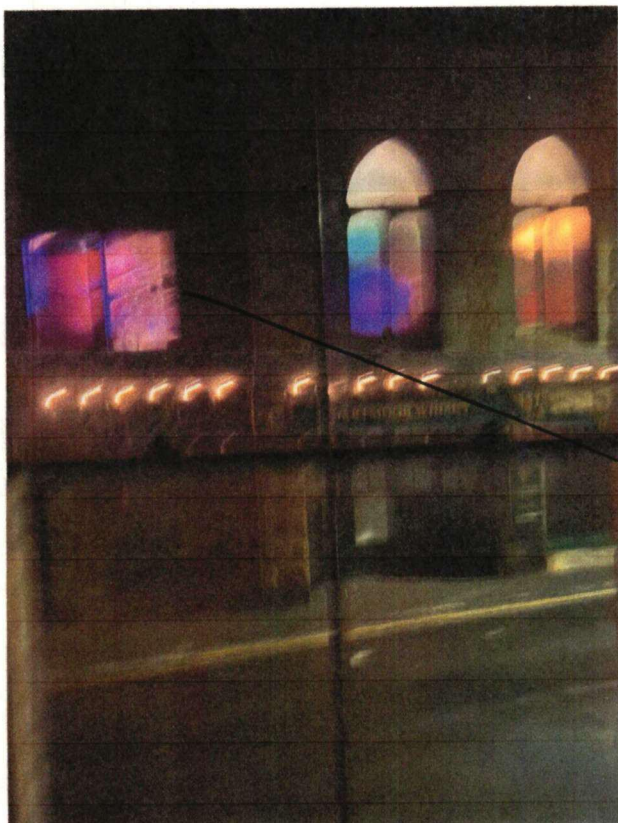

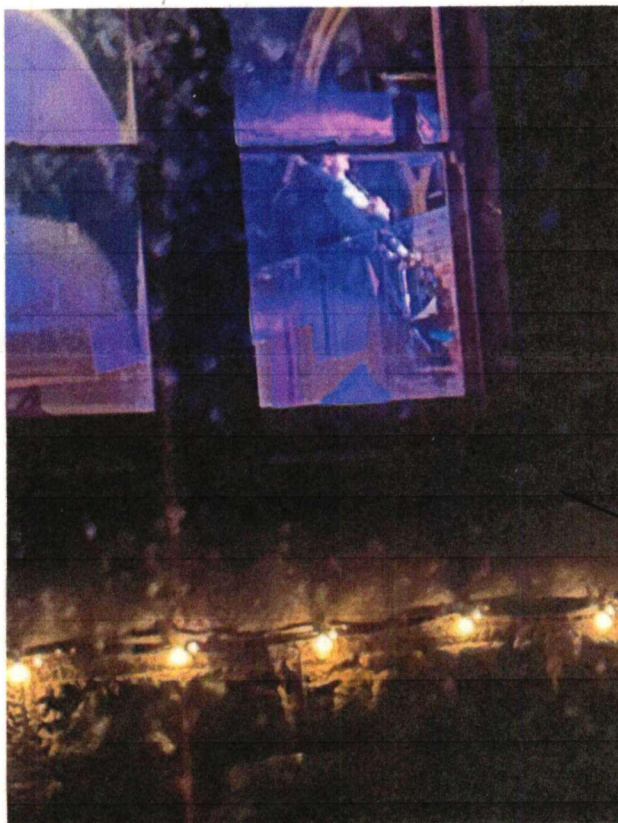
