Item No. 6a

25/01206/FUL - Harewood 17 Torquay Road Kingskerswell

Change of use of existing property from Airbnb guest house to a House of Multiple Occupation (HMO)

The applicant has provided an amended elevation drawing illustrating the door to the pram store.

The applicant advises that the front hard surface area will be reshaped to provide ramped access to the front door.

20/00025/ENF - Land By Jacobs Barn Littlehempston

Unauthorised residential use of the land

Received four letters from local residents opposing the proposed enforcement action and wish the Council to allow the residential use to continue. They consider the current occupiers should be allowed to continue living on the land as they are part of the community and do not have any negative impact on the area.

Received information from the residents on the land who confirm they attend to livestock that are kept on site and that they have been there for about seven years and in that time have become part of the community and taking part in local events. They consider the use of the coach for residential purposes has no impact on the surrounding properties. There is also reference to health issues associated with one of the occupiers.

They wish to continue to live on site to manage the animals and not be a burden on the State as enforcement action would make them homeless and not be able to manage the animals. They would be willing to enter a legal agreement to ensure the residential use ceased when they vacated the land.

There are also concerns about the impact that he proposed enforcement action would have on one of the occupiers. Details of this have been supported by letters from the persons overseeing the occupier's health concerns. To discuss this further it would be necessary to progress the matter in Part 2.

Item No. 8b 20/00182/ENF - Land At Chipley Mill Bickington

Unauthorised change of use of agricultural land to education use (Class F1)

Received one letter from the Parish Council who support the current use. In addition received two letters supporting the proposed enforcement action referring to the flooding issues and the more recent planning history.

Received correspondence from the school referring to previous information submitted. This sets out the need to allow the use of the land as part of the school to continue as it significantly helps the educational development of the children. The children attending the school all have special educational needs and / or disabilities and the school provides a bespoke educational programme for the students which includes using the site at Chipley Mill. This provides an off-school learning environment which helps to nurture the students development. It is considered that to close the Chipley Mill site will have a huge detrimental impact on the student's development, in particular those in their final years of education. It is considered the closure of the site will have significant impact on the students ability to secure the necessary qualifications and have a very real lifelong implications on their futures.

It is requested that the school is allowed to continue using the site. However, if action is to be taken then a request of at least two years to comply is requested. In addition there is reference to an Ofsted report that indicates the school has an 'outstanding' rating which includes the Chipley Mill site where no reference was made to it being unsafe.

With regards to the current use it is noted that only a small number of children attend the site at one time and is not used if there is risk of flooding.

In this instance the school requests that the Committee consider the impact the closure will have on the students. This is in both the short term by not being able to benefit from the facilities currently provided and in the long term with the effect this will have on their educational development.
