3.8 Licensing & Regulatory Committee

3.8.1 Membership: The committee has 11 members who are elected councillors who are appointed at the Annual Meeting of Full Council. Only non-Executive Members are eligible. The committee is politically balanced. The Chair or the Vice-Chair of the Committee will, if in attendance at a sub-committee (comprising up to 3 members of the Committee) dealing with licensing applications and / or appeals, chair the sub-committee; otherwise the sub-committee will appoint a chair for the meeting. Up to three substitute members may be appointed by each political group (see paragraph 3.13 for requirements).

3.8.2 Areas of Work: Within its specific terms of reference below, the committee may appoint sub-committees to deal with its business and wherever possible these will be politically representative, the chair of such being appointed by the sub-committee.

3.8.3 The committee's responsibilities comprise:

- (a) All statutory licensing functions of the Council;
- (b) To hear and determine on behalf of the Council (via its sub-committee), any application or appeal within the committee's terms of reference; and
- (b) To consider and recommend to Council on all matters concerning licensing policy and procedure.

3.8.4 In undertaking its work:

- (a) The proceedings of the committee and any sub-committee shall be conducted with regards to its relevant statutory licensing functions in accordance with the applicable legislation; and
- (b) There is no automatic right for a Teignbridge Councillor to address sub-committee hearings. Councillors wishing to do so must follow the due process for making relevant representations set out in relevant legislation (e.g. Licensing Act 2003).

229. DECLARATIONS OF INTEREST (IF ANY)

230. MINUTES

The Minutes of the Meetings held on 3 October 2025 and 5 November 2025 were approved as a correct record and signed by the Chair.

231. REQUEST FOR HACKNEY CARRIAGE VEHICLE EXTENSION FOR FURTHER 12 MONTHS - DY63 VKL

The Sub-Committee noted the information provided by way of the report. In particular the Sub-Committee noted that the vehicle's MOT certificate expires in November 2026, with no advisories. The vehicle had also passed its annual taxi inspection test with two advisories. The Applicant was in attendance and addressed the Sub-Committee confirming that a garage always services and maintains the car and the suspension issues mentioned in previous MOT's had been fixed.

The Sub-Committee commented that the vehicle appeared to be kept in a good and sound condition although noted the age of the vehicle and higher mileage. The Sub-Committee were satisfied that the vehicle was in a good and sound condition and that public safety would not be compromised by the granting of the licence sought.

Decision

Accordingly, the Sub-Committee granted the Hackney Carriage Vehicle Licence Extension as detailed in the report with the additional condition that the vehicle undergoes a four-month vehicle test to monitor the condition of the vehicle due to its age.

232. REQUEST FOR HACKNEY CARRIAGE VEHICLE EXTENSION FOR FURTHER 12 MONTHS - WD65 DHL

The Sub-Committee noted that the vehicle application had been withdrawn due to no MOT test.

233. REQUEST FOR HACKNEY CARRIAGE VEHICLE EXTENSION FOR FURTHER 12 MONTHS - GM15 GUE

The Sub-Committee noted the information provided by way of the report. In particular the Sub-Committee noted that the vehicle's MOT certificate expires in November 2026, with no advisories. The vehicle had also passed its annual taxi inspection test. The Applicant was in attendance and addressed the Sub-Committee confirming the exhaust emissions had failed due to a DPF filter which has now been changed along with the oil and has the vehicle then passed the test with no further issues.

The Sub-Committee commented that the vehicle appeared to be kept in a good and sound condition although noted the age of the vehicle and higher mileage.

The Sub-Committee were satisfied that the vehicle was in a good and sound condition and that public safety would not be compromised by the granting of the licence sought.

Decision

Accordingly, the Sub-Committee granted the Hackney Carriage Vehicle Licence Extension as detailed in the report with the additional condition that the vehicle undergoes a four-month vehicle test to monitor the condition of the vehicle due to its age.

234. REQUEST FOR HACKNEY CARRIAGE VEHICLE EXTENSION FOR FURTHER 12 MONTHS - AP15 TZS

The Sub-Committee noted that the vehicle application had been withdrawn due to failure of vehicle tests.

235. REQUEST FOR HACKNEY CARRIAGE VEHICLE - KU67 HPL

The Sub-Committee noted the information provided by way of the report, including that the vehicle is over the policy limit as it is 8 years of age. The Sub-Committee noted that the vehicle's MOT certificate expires in April 2026, with no advisories. The vehicle had also passed its annual taxi inspection test with two advisories. The Applicant was in attendance and addressed the Sub-Committee confirming that the headlight had been replaced as had the tyres.

The Sub-Committee commented that the vehicle appeared to be kept in a good and sound condition.

The Sub-Committee were satisfied that the vehicle was in a good and sound condition and that public safety would not be compromised by the granting of the licence sought.

Decision

Accordingly, the Sub-Committee granted the new Hackney Carriage Vehicle Licence as detailed in the report with the additional condition that the vehicle undergoes a six-month vehicle test to monitor the condition of the vehicle due to its age being over the Council's licensing policy.

The Sub-Committee noted that the application had been withdrawn at the Applicant's request.

238. APPLICATION FOR HACKNEY CARRIAGE DRIVERS LICENCE

The Sub-Committee gave consideration to a report presented by the Licensing Officer (previously circulated) in which determination was sought in respect of an application for a new Hackney Carriage Driver's Licence.

The Applicant attended the meeting in person, and answered questions put to him by the Sub-Committee. The Applicant was not accompanied by a representative.

Arising from consideration of the report, evidence presented and in accordance with the Council's procedure for hearings, it was moved by Councillor Hayes and seconded by Councillor Horner, and

RESOLVED that the application for a new Hackney Carriage Drivers Licence be refused under Section 59 (1)(a) of the Local Government (Miscellaneous Provisions) Act 1976, so as to promote public safety. The Sub-Committee felt that the conduct of the Applicant as set out in the Report, supported its view that they are not a fit and proper person to hold such a Licence.

Reasons for the decision:

Members noted the information set out in the report relating to the Applicant's previous conviction for criminal damage and revocation of licence by a neighbouring authority. The Sub-Committee noted that even if convictions are spent, they are still considered relevant as the driving of taxis is a 'Regulated Occupation'. As such questions may be asked as to the suitability of an individual to be granted a licence.

The Sub-Committee noted that the Applicant's licence had been revoked by a neighbouring council due to this conviction and subsequently failing to disclose this within the 7 days required and additionally failing to disclose on reapplication to renew the taxi driver's licence. The Sub-Committee also noted that the conviction and licence revocation were not disclosed on the initial application made to Teignbridge District Council.

The Sub-Committee heard from the Applicant regarding the circumstances that led to the conviction and accepted that this happened some time ago. The Sub-Committee expressed some empathy to the Applicant but considered it necessary to take the conviction into account. The Applicant informed the committee that he had misunderstood the application form and did not think he was required to disclose the conviction due to it being so long ago, and because his basic DBS check had come back clear he thought it was no longer relevant. He had not set out to intentionally mislead the Licensing Officers.

The Sub-Committee thanked the Applicant for appearing before them and noted that he appeared remorseful. However, all factors combined meant that the committee did not consider that the Applicant was a fit and proper person. The Sub-Committee were concerned that the Applicant had not disclosed the conviction on his application and had not spoken to the Licensing Team or the agent acting for him to clarify any potential misunderstandings as to whether he should list them. The Sub-Committee were also concerned that the conviction was one for criminal damage which showed a level of aggression from the Applicant. Taxi drivers are held to a higher standard and may face challenging circumstances that need to be dealt with appropriately. There were concerns from the Sub-Committee about how the Applicant may react to difficult situations due to his history.

Applying the test of whether Members of the Sub-Committee would be happy for a person they cared about or a vulnerable person to travel alone in a vehicle with the Applicant, it was concluded after significant deliberation that they would not. The Sub-Committee noted its overriding duty to the public, and of the importance of public safety and considered that, on balance, there was cause to show that the Applicant was not a fit and proper person to hold a Licence.

The Sub-Committee therefore considered given the circumstances of this case that it be reasonable and proportionate to refuse the application for a new Hackney Carriage Drivers Licence.

239. APPLICATION FOR COMBINED HACKNEY CARRIAGE/PRIVATE HIRE DRIVERS LICENCE

The Sub-Committee gave consideration to a report presented by the Licensing Officer (previously circulated) in which determination was sought in respect of an application for a new combined Hackney Carriage & Private Hire Vehicle Driver's Licence.

The Applicant attended the meeting in person and answered questions put to him by the Sub-Committee. The Applicant was not accompanied by a representative.

Arising from consideration of the report, evidence presented and in accordance with the Council's procedure for hearings, it was moved by Councillor Hayes and seconded by Councillor Peart, and

RESOLVED that the application for a new Hackney Carriage Vehicle Drivers Licence be refused under Section 59(1)(a)(i) and Section 51(1)(a)(i) of the Local Government (Miscellaneous Provisions) Act 1976, so as to promote public safety. The Sub-Committee felt that the conduct of the Applicant as set out in the Report, supported its view that they are not a fit and proper person to hold such a Licence.

Reasons for the decision:

Members noted the information set out in the Report relating to the Applicant's current licence endorsement MS90 - Failure to give information as to the identity of driver, which was received in July 2024. This was received following a speeding offence which occurred in May 2024. The Sub-Committee noted that even if convictions are spent, they are still considered relevant as the driving of taxis is a 'Regulated Occupation'. As such questions may be asked as to the suitability of an individual to be granted a licence. The Sub-Committee were told that the Applicant had been upfront about this offence.

The Applicant explained to the Sub-Committee the circumstances that led to receiving this licence endorsement. He had lent his mother his car and she had been caught speeding. When the letter came through from the police asking for details of the driver the letter was handwritten and did not appear to be genuine. The Applicant thought it was a scam and did not want to provide his mother's details due to this concern. The Applicant passed around copies of the letters he had received from the police which the Sub-Committee considered. The Applicant continued to explain that at around the same time his vehicle numberplate had been cloned, and he had received tickets from London, making him concerned the speeding offence was also a scam.

The Applicant continued and said he had emailed the police who provided him with different contact details to use to confirm if this was a scam, but he received no response to his email. Following this, once he finally became aware this wasn't a scam, he then wrote to the police and courts to explain the confusion and accept the charge. The Applicant explained he had misunderstood the UK system and once aware he complied fully with what was requested. In response to questions the Applicant confirmed that his mother was fully insured and able to drive the car legally.

The Sub-Committee thanked the Applicant for appearing before them and for answering their questions. However, all factors combined meant that the Sub-Committee did not consider that the Applicant was a fit and proper person. The Sub-Committee noted that the Applicant appeared remorseful and other than the offence in question the Applicant's record appeared clear. They also noted that he had disclosed the offence on his application. However, the Sub-Committee were not completely satisfied by the reasons given by the Applicant for believing that the letters received from the police were a scam and therefore not providing details as legally required.

The Sub-Committee had seen the letters received from the police which were on headed paper and the information relating to the offence was the only handwritten part of these. The Sub-Committee felt these looked official and did not feel that they could have been mistaken for a scam. The Sub-Committee also felt that if the Applicant was truly concerned about a scam, he should have followed this up more thoroughly with the Police and chased if a response had not been received from any enquiries he made.

The Sub-Committee felt that by not disclosing who had been driving the car this indicated dishonesty over who had actually been driving and perhaps this had in fact been intentional. There was concern due to this that the Applicant was not a fit and proper person to hold a licence at this time.

Applying the test of whether Members of the Sub-Committee would be happy for a person they cared about or a vulnerable person to travel alone in a vehicle with the Applicant, it was concluded after significant deliberation that they would not. The Sub-Committee noted its overriding duty to the public, and of the importance of public safety and considered that, on balance, there was cause to show that the Applicant was not a fit and proper person to hold a Licence.

The Sub-Committee therefore considered given the circumstances of this case that it be reasonable and proportionate to refuse the Applicant's application for a new Combined Hackney Carriage & Private Hire Drivers Licence.

243. REQUEST FOR HACKNEY CARRIAGE VEHICLE EXTENSION FOR FURTHER 12 MONTHS - H574

The Sub-Committee noted the information provided by way of the report. In particular the Sub-Committee noted that the vehicle's MOT certificate expires in August 2026, with no advisories. The vehicle had also passed its annual taxi inspection test on 3 December 2025. The Applicant was not in attendance and did not send a representative.

The Sub-Committee commented that the vehicle appeared to be kept in a good and sound condition although noted the age of the vehicle was now above the Council's policy.

The Sub-Committee were satisfied that the vehicle was in a good and sound condition and that public safety would not be compromised by the granting of the licence sought.

Decision

Accordingly, the Sub-Committee granted the Hackney Carriage Vehicle Licence Extension as detailed in the report with the additional condition that the vehicle undergoes a six-month vehicle test to monitor the condition of the vehicle due to its age.

Accordingly, the Sub-Committee granted the Hackney Carriage Vehicle Licence Extension as detailed in the report with the additional condition that the vehicle undergoes a six-month vehicle test to monitor the condition of the vehicle due to its age.

The Sub-Committee were satisfied that the vehicle was in a good and sound condition and that public safety would not be compromised by the granting of the licence sought.

Accordingly, the Sub-Committee granted the Hackney Carriage Vehicle Licence Extension as detailed in the report with the additional condition that the vehicle undergoes a six-month vehicle test to monitor the condition of the vehicle due to its age.

246. REQUEST FOR HACKNEY CARRIAGE VEHICLE EXTENSION FOR FURTHER 12 MONTHS - H616

The Sub-Committee noted the information provided by way of the report. In particular the Sub-Committee noted that the vehicle's MOT certificate expires in November 2026, with 3 advisories. The vehicle had also passed its annual taxi inspection test on 20 November 2025. The Applicant was in attendance and was given a chance to address the Sub-Committee. The Applicant confirmed that the advisories on the MOT had all been fixed.

The Sub-Committee commented that the vehicle appeared to be kept in a good and sound condition although noted the age of the vehicle was now above the Council's Hackney Carriage and Private Hire vehicle licensing policy.

The Sub-Committee were satisfied that the vehicle was in a good and sound condition and that public safety would not be compromised by the granting of the licence sought.

Decision

Accordingly, the Sub-Committee granted the Hackney Carriage Vehicle Licence Extension as detailed in the report with the additional condition that the vehicle undergoes a six-month vehicle test to monitor the condition of the vehicle due to its age.

247. REQUEST FOR HACKNEY CARRIAGE VEHICLE EXTENSION FOR FURTHER 12 MONTHS - H580

The Sub-Committee noted the information provided by way of the report. In particular the Sub-Committee noted that the vehicle's MOT certificate expires in December 2026, with no advisories. The vehicle had also passed its annual taxi inspection test on 10 December 2025 with 4 advisories. The Applicant was in attendance and was given a chance to address the Sub-Committee. The Applicant confirmed that the advisories on the vehicle test would be fixed in time.

The Sub-Committee commented that the vehicle appeared to be kept in a good and sound condition although noted the age of the vehicle was above the Council's Hackney Carriage and Private Hire vehicle licensing policy.

The Sub-Committee were satisfied that the vehicle was in a good and sound condition and that public safety would not be compromised by the granting of the licence sought.

Decision

Accordingly, the Sub-Committee granted the Hackney Carriage Vehicle Licence Extension as detailed in the report with the additional condition that the vehicle undergoes a six-month vehicle test to monitor the condition of the vehicle due to its age and advisories listed.

RESOLVED: that the meeting move into Part II to consider the following agenda items.

249. APPLICATION FOR COMBINED HACKNEY CARRIAGE/PRIVATE HIRE DRIVERS LICENCE

The Applicant attended the meeting in person with his wife and he answered questions put to him by the Sub-Committee.

Arising from consideration of the report, evidence presented and in accordance with the Council's procedure for hearings, it was moved by Councillor Peart and seconded by Councillor Horner; and

RESOLVED that the application for a new Hackney Carriage / Private Hire Drivers Licence be refused under Section 51 (1)(a) and 59 (1)(a) of the Local Government (Miscellaneous Provisions) Act 1976, so as to promote public safety. The Sub-Committee felt that the conduct of the Applicant as set out in the Report, supported its view that they are not a fit and proper person to hold such a Licence.

Reasons for the decision:

Members noted the information set out in the report relating to the Applicant's revocation of a taxi licence by a neighbouring authority in July 2024. The Sub-Committee noted that the Applicant's licence had been revoked by a neighbouring council due to failing to report a collision and being dishonest as to the circumstances of this collision. The Sub-Committee noted that the licence revocation was disclosed on the initial application made to Teignbridge District Council.

The Sub-Committee heard from the Applicant regarding the circumstances that led to the collision and in response to questions he confirmed that he hadn't reported the collision and had been dishonest as to the circumstances as it had never happened to him before, he was unsure what he should do and worried he would lose his licence which he needs to support his family. He has been driving taxis since 2016 and regrets what happened. The Applicant continued and stated he really regrets what happened but that at the time he was under a lot of stress in his personal life, and it had all become too much for him.

In response to further questions relating to speeding offences which were not declared to the previous authority, the Applicant explained that he thought the DVLA check carried out on all drivers by Local Authorities would confirm this and therefore he didn't need to report it. The Licensing Officer then clarified to the Sub-Committee that they always check DVLA licences for new drivers and intermittently for current drivers. The Licensing Officer also explained that there will always be a specific time frame for reporting any incidents and for providing evidence a vehicle is safe to drive, although this may differ between Licensing Authorities.

The Applicant confirmed to the Sub-Committee that the vehicle had scratches and a small dent resulting from the collision. A garage was contacted straight away to fix these. The Applicant again stated his regret for what happened and acknowledged his mistake. He is asking for a chance to prove himself and show he is a responsible person who can safely carry passengers.

The Sub-Committee thanked the Applicant for appearing before them and noted that he appeared remorseful. However, all factors combined meant that the committee did not consider that the Applicant was a fit and proper person.

The Sub-Committee noted that whilst the licence revocation had been declared by the Applicant, the circumstances surrounding the collision and subsequent revocation were concerning. The Sub-Committee felt that there appeared to have been a series of bad decisions made by the driver who had been licensed for some years and that the behaviour fell well below that expected of a licensed driver. The Sub-Committee also noted the dishonesty surrounding the circumstances of collision which happened when a child was in the car, which only came to light once the previous Licensing Authority received a complaint.

There were further concerns that the Applicant had received convictions for exceeding the statutory speed limit on two occasions which were not disclosed to the previous Licensing Authority and that the CCTV footage of the collision showed the vehicle appeared to be driving too fast for the road conditions, further putting the public at risk.

Taxi drivers are held to a higher standard and may face challenging circumstances that need to be dealt with appropriately. There were further concerns from the Sub-Committee about how the Applicant may react to difficult situations due to his history of dishonesty when reporting incidents.

Applying the test of whether Members of the Sub-Committee would be happy for a person they cared about or a vulnerable person to travel alone in a vehicle with the Applicant, it was concluded after significant deliberation that they would not. The Sub-Committee noted its overriding duty to the public, and of the importance of public safety and considered that, on balance, there was cause to show that the Applicant was not a fit and proper person to hold a Licence.

The Sub-Committee therefore considered given the circumstances of this case that it be reasonable and proportionate to refuse the application for a new Combined Hackney Carriage / Private Hire Drivers Licence.

250. APPLICATION FOR COMBINED HACKNEY CARRIAGE/PRIVATE HIRE DRIVERS LICENCE

The Applicant attended the meeting in person, and he answered questions put to him by the Sub-Committee. The Applicant did not have a representative.

Arising from consideration of the report, evidence presented and in accordance with the Council's procedure for hearings, it was moved by Councillor Peart and seconded by Councillor Horner, and

RESOLVED that the application for a new combined Hackney Carriage / Private Hire Driver's Licence be granted under Section 51(1)(a) and Section 59(1)(a) of the Local

Government (Miscellaneous Provisions) Act 1976. The Sub-Committee felt that the conduct of the Applicant, supported its view that they are a fit and proper person to hold such a Licence.

Reasons for the decision:

Members noted the information set out in the Report relating to the Applicant's caution and the reasons why the application for a licence was refused at officer level. The Licensing Officer stated that the caution was not disclosed on the application or during the driver interview.

The Applicant was given an opportunity to address the Sub-Committee and clarified that he had declared the caution to his agent who had omitted to include this. His agent had subsequently sent a letter through explaining that the Applicant had declared everything and that it was omitted from the application form in error. The Applicant further explained that he was interviewed by one officer and only asked one question which was how he should park in a taxi parking bay, but the caution itself was not raised although he was prepared to talk about it if questioned.

The Licensing Officer explained that at the time of interview they were not aware of a caution as the DBS certificate had not been received, and it had not been declared. The Applicant stated that at this point he was unaware that the caution had not been disclosed and felt that it was unreasonable to expect him to raise this again. The Applicant also noted that the agent's letter did not appear to have been included as part of the report, although the omission was mentioned in the officer's presentation at the start of the hearing.

The Licensing Officer explained to the Sub-Committee the process of submitting an application and felt that the Applicant should maybe have mentioned the caution during the interview. The Applicant then confirmed he had not been asked any questions at interview and that the interviewee had said she didn't know what she was doing because it was new and that whilst he does not like to acknowledge the caution, he was prepared to speak about it if questioned. He had been upfront with his agent who had said it should not be an issue, but they would disclose it in any event.

The Sub-Committee asked the Licensing Officer the process of the interview as if an Applicant is not asked specific questions, then they wouldn't necessarily expect to answer or bring the issue up. The Licensing Officer explained that public safety is paramount, and the driver's interview is not a normal interview with set questions such as if applying for a job. It is to help establish if someone is 'fit and proper' to hold a licence taking into consideration that decisions on suitability are made on the balance of probability and applicants should not be given the benefit of the doubt. If the officer is only '50/50' as to whether the applicant or licensee is 'fit and proper', they should not hold a licence. The Applicant then clarified that he does not remember being asked any questions and that it seems unfair for the onus to be on an applicant to bring up issues, questions or responses if not asked. The Licensing Officer responded and explained to the Sub-Committee that questions were asked at interview based on specific parts of the policy that were handed to the applicant to read.

The Applicant continued and stated that he accepts responsibility for the incident. And is taking steps with his doctor to help balance his mood to be able to deal with incidents in a more neurotypical way. The Applicant really feels that this is helping and doesn't believe any issues have been raised about him since. The Applicant understands how it looks but he stressed that whilst he can overreact on issues that are really important to him, there is nothing else on his record and he understands the responsibilities he would have as a taxi driver.

The Licensing Officer added that the applicant was interviewed by 2 officers, and that the Applicant had initially stated he had been asked one question at interview and then stated he had not been asked any and further said he couldn't remember.

The Committee thanked the Applicant for appearing before them and noted that he had taken responsibility for what had happened. The Sub-Committee felt that the Applicant's attitude to the caution and the fact that he has been obtaining support from his doctor to prevent further incidents indicated that he was a fit and proper person to hold a licence.

When considering the Council's Taxi and Private Hire Policy the Sub-Committee were mindful that each case must be decided on its own merits. The Sub-Committee considered that this appeared to have been an isolated incident, and no other concerns had been raised about the Applicant since. The Sub-Committee also noted that there had appeared to have been a massive mix-up in relation to the application form and declaration of the caution with no obvious intent to deceive. The Sub-Committee could also understand why the Applicant had not brought up the caution during the interview process.

The Sub-Committee noted its overriding duty to the public, and of the importance of public safety but considered that, on balance, there was no cause to show that the Applicant was a risk to the public and was not a fit and proper person to hold a Licence.

Applying the test of whether Members of the Sub-Committee would be happy for a person they cared about or a vulnerable person to travel alone in a vehicle with the Applicant, it was concluded after significant deliberation that they would.

Taking the Council's Licensing Policy into consideration, along with the Applicant's submissions, the Sub-Committee considered given the circumstances of this case that it be reasonable to approve the Applicant's request for a new combined Hackney Carriage / Private Hire Drivers Licence as set out in the report.

A vehicle being presented for subsequent licensing is required to be under 10 years old with the exception of purpose-built cabs. The Council has discretion to continue to licence Hackney Carriage or Private Hire vehicles which are older than ten years provided that the Council is satisfied that the vehicle is in a good condition and good state of repair and provided that it passes the appropriate testing standard. Applications for subsequent licensing for vehicles older than ten years will be considered by the Licensing and Regulatory Committee which can impose such conditions as it thinks fit including six and four monthly testing'.

- 2.2 All vehicle licences are issued annually.

- 2.3 Section 48(4)(c) of the Local Government (Miscellaneous Provisions) Act 1976 states that:

'Every licence granted under this section shall— (c) remain in force for such period not being longer than one year as the district council may specify in the licence'.

- 2.4 Section 48(2) of the Local Government (Miscellaneous Provisions) Act 1976 states that:

'A district council may attach to the grant of a licence under this section such conditions as they may consider reasonably necessary including, without prejudice to the generality of foregoing provisions of this subsection, conditions requiring or prohibiting the display of signs on or from the vehicle to which the licence relates.'

- 2.5 The above Policy and statutory provisions reflect the Council's responsibility to ensure that all hackney carriage and private hire vehicles are safe and fit for use by members of the public. The Committee has the discretion to license a vehicle if it is of the view that the vehicle is safe, fit for use and is in an acceptable condition.

- 2.6 The decision of the Committee following a complete review of the Hackney Carriage and Private Hire Policy in April 2009, after taking into account the views from the trade, were as follows:

"The Committee decided that vehicles being presented for initial licensing must be under five years old."

2.7 With regard to subsequent licensing, the Committee decided that a vehicle should be under ten years old with the exception of purpose-built cabs. However, the Committee decided that the Council could exercise discretion to continue to licence Hackney Carriage or Private Hire vehicles which are older than ten years provided that the Council is satisfied that it is in a good condition and good state of repair and provided that it passes the appropriate testing standard. Applications for subsequent licensing for vehicles older than ten years will be considered by the Licensing and Regulatory Committee which can impose such conditions as it thinks fit including six monthly testing. The Committee did not consider it appropriate to introduce an upper age or mileage limit.”

2.8 Section 50(1) of the Local Government (Miscellaneous Provisions) Act 1976 provides:

‘that a district council shall not under the provisions of this subsection require a proprietor to present the same hackney carriage or private hire vehicle for inspection and testing on more than three separate occasions during any one period of twelve months.’

3. FINANCIAL IMPLICATIONS


