#### First questions

The phrase community led is often bandied about in the chamber, at Executive and Overview & Scrutiny Meetings, as well as at Full Council meetings. What is the definition of 'community-led' that this council uses to define itself this way?

#### 10/07/25 Cllr P Parker to the Leader of the Council

In relation to the committee seat allocations approved at the recent Full Council meeting, can the Leader confirm how the final arrangements comply with the statutory requirements of Sections 15 to 17 of the Local Government and Housing Act 1989 and the Local Government (Committees and Political Groups) Regulations 1990, given that the vote approving the allocations was not unanimous and therefore, under law, cannot support any deviation from strict political proportionality?

#### Response from the Leader of the Council

We have always sought advice from the Monitoring Officer on matters relating to law and complied. The seat allocations are an ever-moving feast of Councillors changing party's or leaving the Council. As we are witnessing this month!

On what legal basis were the last-minute changes to the proposed committee seat allocations introduced by the Liberal Democrat group without prior consultation with the Independent Group permitted to override the previously proportional and more widely acceptable arrangements?

#### Third questions

#### 12/5/2025 Cllr MacGregor to the Leader of the Council

Zero Tolerance was one of the aspects voted for at the Full Council meeting and as a result of the Grant Thornton statutory recommendation. Is this going to be applied consistently to all councillors equally?

#### Response to the Leader of the Council

Yes, it is for all Group Leaders to model good behaviour and ensure their group complies with the Code of Conduct.

Will the administration confirm that in future, if a departure from political proportionality is proposed, all members will be explicitly informed in advance that such a deviation requires unanimous agreement in accordance with the law?

#### Response from the Leader of the Council

Yes, if the Council agrees under Section 17 to disapply sections 15 and 16 of the Act.

#### Fourth questions

In light of the recent UK Supreme Court judgement will the outgoing chair of council, outgoing chair of Overview and Scrutiny and the several councillors who disparaged concerns raised, apologise to those members of the public that they interrupted and shut down at every opportunity?

#### Response from the Leader of the Council

That is for those Members to decide themselves if they felt appropriate to do so.

#### 10/07/25 CIIr P Parker to the Leader of the Council

If the current allocations are not to be revisited and recalculated strictly in line with Sections 15 and 16 of the 1989 Act, will the Council provide a copy of the written external legal advice relied upon to justify the course of action taken and explain how it has been reconciled with the relevant statutory duties?
