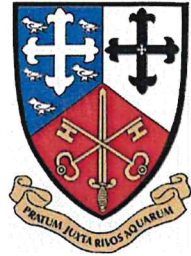

GENERAL NOTICE OF REGISTERABLE INTERESTS

GENERAL NOTICE OF
REGISTRABLE INTERESTS**



The Teignbridge District Council Members' Code of Conduct (2021) can be found in the Council's Constitution. The current requirements are currently under review by central government and also locally. Whilst changes may be made over the coming months, pending this all of the Council's members are required to register various interests as explained below.
